The Alabama Board of Physical Therapy Practice Act, allows a recent graduate of an approved physical therapy education program, who has met all other requirements in AL for licensure but who has not yet successfully completed the licensing exam in this state or another state, to be engaged in direct patient care as a PT/PTA graduate under the direct onsite overseeing of the performance of assigned or delegated duties or functions. Supervision must be by an Alabama licensed physical therapist or physical therapist assistant.

## The graduate PT/PTA must have submitted to the Boards Office:

- An application for license.
- \$150 application fee to the Board.
- Required two-character references.
- College or university provided Certificate of Physical Therapy Education form or official transcript.
- Registered and paid the Federation of State Boards of Physical Therapy for the NPTE exam following the graduation date.

The attached form must be completed and returned to this Board prior to consideration for temporary licensure. You and the Alabama registered physical therapist who will be supervising you should complete the form and return it to the above address.

Please note - you may meet all requirements to take the licensing examination in Alabama without a temporary license. A temporary license is not a requirement in order to sit the exam.

If you have previously taken the licensing examination and failed, you will not be eligible for temporary licensure in Alabama.
